Submission is a representation that the manuscript has not been published previously and is not currently under consideration for publication elsewhere. Authors should provide indexing codes according to the PACS scheme (available at <http://publish.aps.org/PACS/>). An executed APS **copyright-transfer** form (effective only on acceptance for publication) must be provided; the form is available via our Web submission server and via <http://authors.aps.org/>.

To help defray editorial and production expenses, authors of published Letters are expected to pay a **publication charge** of \$670 (\$235 for a Comment or Reply). Charges are higher (\$825 for a Letter, \$300 for a Comment or Reply) for those which are not submitted in an acceptable electronic format. Acceptable formats are REVTeX (preferred), L<sup>A</sup>T<sub>E</sub>X, plain T<sub>E</sub>X, MS Word; PostScript figures (preferred). **Reprints** are offered for sale to authors.
