Authors should provide indexing codes according to the PACS scheme (available at <http://publish.aps.org/PACS/>). An executed APS copyright-transfer form (effective only on acceptance for publication) must be provided; the form is available via our Web submission server and via <http://authors.aps.org/>. To help defray editorial and production expenses, authors of published Letters are expected to pay a publication charge of \$730 (\$265 for a Comment or Reply). Charges are lower (\$590 for a Letter, \$210 for a Comment or Reply) for properly prepared electronic submissions. Acceptable formats are REV<sub>L</sub>TEX (preferred), L<sup>A</sup>T<sub>E</sub>X, plain T<sub>E</sub>X, MS Word; PostScript figures. Reprints are offered for sale to authors.
